(i) Kayachikitsa, (ii) Shalya Tantra - Samanya and (iii) Stree Rog & Prasuti Tantra with 6 seats in each subjects under Section 13A of the IMCC ACT, 1970 from the academic session 2017-18 - **Permission Letter** -reg.


Sir,

In continuation to the Ministry's letter of even No. dated 22.06.2017 wherein a Letter of intent was issued to the aforesaid trust to start new Post Graduate Course of Study in 03 subjects with respect to the proposal submitted to the Central Government as cited above, I am directed to say that after careful consideration of the recommendations & report of the CCIM in terms of criteria as specified in the Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) and (Post Graduate Ayurveda Education) Regulations, 2016; provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approval of the Hon'ble MoS (IC), Ministry of AYUSH for the UG/PG course(s) for grant of conditional permission for the academic session 2017-18 vide Ministry's letters No.R.11011/03/2017-EP (IM-1) dated 12.06.2017; **permission** of the Central Government is hereby granted to the **Shree Saptashruni Ayurved Mahavidyalaya & Hospital, Kamal Nagar, Hirawadi, Panchavati, Nasik- 422003, Maharashtra to start new Post Graduate Course of Study in 03 subjects viz. (i) Kayachikitsa, (ii) Shalya Tantra - Samanya and (iii) Stree Rog & Prasuti Tantra with 6 seats in each subjects from the academic session 2017-18 to the academic session 2018-19 under section 13A of the IMCC Act, 1970. Therefore, the college may take admissions for the academic session 2017-18 and 2018-2019.**

2. This permission to start new Post Graduate Courses in 03 subjects as stated above for the first admitted batch of 2018-19 session, will be valid till such time as the first batch of students admitted against these courses appear for the first final examination of the said courses and at that time, the College authorities may take up the matter for recognition of the qualifications under Section 14(2) of the IMCC Act, 1970.

3. The college administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the relevant CCIM Regulations, are in position before the



admission of the students in the above-mentioned courses as per permitted PG seats are made, under intimation to the Central Government and CUM.

4. Further, to obtain the permission for academic session 2019-20 onwards and to take admissions in the above said new permitted 03 PG courses, the college shall maintain all the Requirements of infrastructure and teaching & training facilities as specified under regulations 4 to 11 of the Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, provisions of the IMCC Act, 1970 and relevant Regulations made thereunder in toto during the period of permission (i.e. up to 2018-19) as intimated by Ministry vide letter no.R.17011/153/2014-EP (IM-1) dated 04.08.2014 which may be verified either by the Central Government or by the Central Council of Indian Medicine on receipt of any complaint. Further, as per the provisions of Sub-Regulation (1) (b) of Regulation 3 of the RMS Regulations, 2016, the Central Council shall visit the college *suo moto* three months before the expiry of permission to verify the requisite infrastructure and facilities required under above mentioned Regulations by means of an inspection and shall submit a report to the Ministry of AYUSH for considering the permission matter from the academic session 2019-20.


